- Candidates from all categories (including Open/General) may apply for the posts in various departments, provided they meet the required subject/ specialization criteria.
- (2) The appointment will be made strictly in accordance with the provisions of The Gujarat Public Universities Act-2023, Gujarat Public Universities Uniform Statutes, 2024 as well as the relevant prevailing norms of UGC, AICTE, NCTE, Statute No. 131 of Gujarat Public Universities Uniform Statutes, 2024 and any other applicable regulatory bodies.
- (3) In case no suitable candidate is found for a particular specialization of concerned subject, candidates from allied or relevant specializations may be considered, subject to due verification and scrutiny by the university.

<u>General instructions for the post of Temporary Assistant Professor</u> <u>Employment Notice No.: GAD/TAP/E.N./12711/2025</u>

- 1. The appointment of Temporary Assistant Professor (TAP) in the university's program is purely temporary, on a contractual basis for 11 months (up to the end of the second term of the Academic Year 2025-26), funded by the university. The appointment will automatically terminate upon the completion of the 11- month contract (second term of the Academic Year 2025-26) without notice, or earlier if the university appoints a regular faculty member.
- 2. The selected candidate will be entitled to a consolidated remuneration of Rs. 40,000/- per month, or an amount finalized as per the decision of the university authorities..
- 3. Applicants must submit their applications through the online recruitment portal at <u>https://rms.vnsgu.net</u> on or before <u>dt.09/06/2025</u> by 11:59 p.m. and upload all necessary documents with the online application. A separate application is required for each post.
- 5. Applicants who are already employed must apply through their current employer. However, if there is any unavoidable delay in submitting the application through the proper channel, an advance copy may be sent before the due date. Candidates who are employed at the time of applying must bring a "No Objection Certificate" from their employer at the time of the interview.

Agreement

Agreement entered into this DAY of DD-MM-YYYY between NAME OF TEMPORARY ASSISTANT PROFESSOR (here in after called the Temporary Teaching Assistant /Temporary Assistant Professor of the one part and the Veer Narmad South Gujarat University, being a Body corporate constituted under the Veer Narmad South Gujarat University Act, 1965 (herein after called the University) of the other part). Whereas by the resolution of the University passed by the Board of Management at its meeting held on the __/____ it was resolved to appoint Temporary Assistant Professor as per requirement of University. Accordingly, Temporary Assistant Professor appointed in the department of ______ /Self Finance Programme on purely temporary contract basis (completion of second term of academic calendar) subject to the conditions of service as may be laid down by University from time to time. AND WHEREAS the Temporary Assistant Professor accepted the said terms of appointment and agreed to join the University service, AND FURTHER WHEREAS it has been considered desirable to record in writing, the terms and conditions of service agreed to between the Temporary Assistant Professor and the University. NOW THESE PRESENTS WITNESS that it is hereby agreed by and between the parties as follows:

- The appointment as a ______ is purely on temporary bases on contract up to the last day of the second term of the academic year _____.
- (2) Your appointment will automatically end on Appointment of GIA/SFT (Permanent) Assistant Professor/ Associate Professor/Professor.
- (3) The appointment will automatically stands cancelled on the last day of the second term of Academic year 2025-26 without notice.
- (4) Selected candidate is entitled to get an honorarium of INR_____ per month or final as per decision of University authority.
- (5) Since this a purely temporary post on contract basis, benefits of provident funds, Gratuity, Leave Travel concession and Medical Benefits etc. shall not be admissible.
- (6) Temporary Assistant Professor shall not be engaged in any other part time/full time employment.
- (7) The appointment on a purely temporary basis and can be terminated during assignment of the contract without giving notice or without assigning any reason thereof when your services for teaching or other academic work are not required by the University.
- (8) The appointment is also liable to be terminated at any time if the University is not satisfied with the work or conduct of Temporary Assistant Professor without giving any notice.
- (9) The appointment shall not confirm any right or entitlement for claiming absorption against any vacancy or post.

- (10) Temporary Assistant Professor will be entitled for one (1) leave each month with prior permission of Head of the department /Coordinator/Principal.
- (11) Temporary Assistant Professor has to produce original certificate and testimonials for verification before joining your duties.
- (12) Temporary Assistant Professors shall have working hours from 10:30 AM to 5:30 PM, or as directed by the Head of the Department/Coordinator/Principal.
- (13) The Code of professional ethics for university and college teachers 1989 that has been adopted by UGC (Annexure XX) shall be applicable to Temporary Assistant Professor/Temporary Teaching Assistant.
- (14) Temporary Assistant Professor shall be obliged to conduct themselves in an ethical, responsible and professional manner. They shall perform duties (viz. teaching, research, co-curricular activities, extra-curricular activities, patent filling etc.) with dedication. They shall also be required to assist the university in administrative activities (viz. general management, admissions, counseling, invigilation, placement related activities like job fairs and follow up, start-up and innovation related activities, exam section related activities like question paper and answers sheet management and transportation, any other activities taken up by the university).
- (15) Temporary Assistant Professor shall maintain their private affairs in a manner consistent with the dignity of the profession.
- (16) Temporary Assistant Professor shall refrain from conduction private tuitions/coaching classes which are likely to interfere in their professional responsibilities.
- (17) Unless implicitly permitted Temporary Assistant Professor are forbidden to raise funds for any purpose whatsoever.
- (18) Temporary Assistant Professor will abide by the conditions of service and discipline rules as laid down by the University from time to time.
- (19) Temporary Assistant Professor has to keep and maintain strict confidentiality and privacy of information, data and secrets of examination work of the University.
- (20) There will be performance review of Temporary Assistant Professor every 05 month if performance review does not meet performance your order shall be automatically cancelled.
- (21) Temporary Assistant Professor [both genders] must do all administrative work which may require to travel out of station and for extended hours.
- (22) Temporary Assistant Professor are required to maintain a professional dress code that is in keeping with the customs and traditions.
