NOW THESE PRESENTS WITNESS that it is hereby agreed by and between the parties as follows:

- (1) The appointment as a Temporary Assistant Professor (Adhoc/Contractual)/ Temporary Teaching Assistant (Adhoc/Contractual)/ is purely on temporary bases on contract of 11 months.
  - (i) Your appointment will automatically end on Appointment of GIA (Permanent) Assistant Professor/Associate Professor/Professor.
- (2) The appointment will automatically end on completion of 11 months (second term of Academic year 2023-2024) without notice.
- (3) Selected candidate is entitled to get an honorarium of Rs. 25,000/- per month or final as per decision of University authority..
